Workers in South Urged to Come Directly Under Banner of William Green.

Anniston, Ala., April 27.-(AP)-The American Federation of Labor opened a drive today on an opposition stronghold-cotton textilesin its southern conflict with John L. Lewis' Committee for Industrial Organization.

George Googe, ranking southern officer of the A. L. of L. challenged the Lewis labor group in an address here before the Alabama Federation of Labor, which has been "purged" of Lewis supporters on Googe's instructions.

Textile workers already are organized in many southern mills under the Lewis banner as members of the United Textile Workers of

Organizers to Take Field.

Googe, emissary in the south of A. F. of L. President William Green, said organizers would take the field immediately in "a clarion call to the banner of the A. F. of L. and true Americanism."

Before delegates from Alabama's craft unions, he condemned the "sit-down and slow-down strike" and pledged the federation to work against "the subversive proponents of foreign ideals, imported from Moscow, Berlin and the orient."

"The time has arrived," he said, "when the integrity or even the existence of American trade unionism and of our American system of government are at stake."

Discussing the textile organization drive, Googe said it would be made "by southerners for southerners." He said the federation planned to urge the 320,000 textile workers to come directly under the A. F. of L.



10 TO SHARE REWARD IN VAN HOOSE CASE

Half of \$1,750 Offered by Widow, C. of C. and City Goes to Former Camp Proprietor.

Carthage, Mo., April 27.-Ten persons will share the \$1,750 reward offered by the Chamber of Commerce, Mrs. B. L. Van Hoose and the city of Carthage in the B. L. Van Hoose murder case, the chamber reward committee has decided, according to the committee's report filed today.

Mrs. Van Hoose offered \$1,000 for the arrest and conviction of the slayers of her husband at the Van Hoose some southwest of here the night of March 3, 1934, while the Chamber of Commerce offered \$500 and the city of Carthage \$250. The findings of the reward committee governed the three awards. Other Rewards Offered.

Total rewards amount to \$2,250, including \$300 offered by the state and \$250 by Jasper county. The chamber committee decision had no affect on the rewards offered by the county and the state. Those on the reward committee were John H. Flanigan, G. Everett Hough and George S. Beimdiek.

Half of the reward, or \$875, goes o Robert E. Dugan, an employe at the Brown billiard parlor who at the time of the killing of Mr. Van Hoose was proprietor of the Sleepy Hollow camp northeast of here on highway 66. He gave information which led to identification of the
